STATEMENT OF BELIEFS (One parent must sign.)

Our support group has chosen to be a "restricted membership" group. This simply means that all members share the same basic beliefs concerning Jesus Christ. We do not consider ourselves to be a "clique" nor do we feel that we are better than anyone else. However, since we do believe that the purpose of the support group is to develop close relationships both for our children and ourselves, we do not consider the support group to be a ministry of evangelical outreach.

The following items are what we consider to be basic to a relationship with Jesus Christ. Please read these and the Scripture references cited. If you have any questions, please talk to the Heritage Christian School Leader or a member of the Advisory Board. If you also share these beliefs, sign the *Confirmation of Beliefs* and return it to the Membership Coordinator with your other membership materials.

1. I believe that the Bible is the inspired and only infallible, authoritative written Word of God. *2 Tim 3:16, Deut 4:2, Rev 22:18-19*
2. I believe that there is only one God, eternally existent in three persons: Father, Son, and Holy Spirit. *Matt 28:19, John 14:16-17*
3. I believe that Jesus Christ was begotten by the Holy Spirit, born of the virgin Mary, and is true God and true man. *Matt 1:18-23*
4. I believe in Jesus' sinless life. *2 Cor 5:21*
5. I believe that man was created in the image of God. *Gen 1:26*
6. I believe that man sinned, and thereby incurred not only physical death, but also spiritual death which is separation from God. *Rom 3:23, Rom 6:23*
7. I believe that the Lord Jesus Christ died for our sins, according to the Scriptures, as a representative and substitutionary sacrifice; and that all who believe in Him are justified on the grounds of His shed blood. *Rom 5:8-9*
8. I believe that all who receive by grace, through faith, the Lord Jesus Christ, are born again of the Holy Spirit, and thereby become children of God. *Eph 2:8-9, John 1:12*
9. I believe in the bodily resurrection of Christ and His ascension to the right hand of the Father and in His present work as High Priest and Advocate. *1 Cor 15:3-4, Mark 16:19*
10. I believe in the personal return of Jesus Christ. *Acts 1:11*
11. I believe in the bodily resurrection of the just to everlasting life and the unjust to everlasting punishment. *Matt 25:46, Acts 24:15*
12. I have received Jesus Christ as my Lord and Savior. *Rom 10:9*

minor children (hereinafter called Homeschoolers) for the benefit of Heritage Christian Home School, and its successors, leaders, officers, advisory board members, and their heirs and assigns (herein after called Released Parties).

Homeschoolers understand that Heritage Christian Home School is an informal nonprofit organization composed of homeschooling parents and that it does not maintain insurance. Homeschoolers further understand that they would not be allowed to participate in Heritage Christian Home School without this Release being signed.

FOR AND IN CONSIDERATION of the privilege of participating in Heritage Christian Home School, a Christian home school support group, Homeschoolers, for themselves, their children, and their respective estate representatives and assigns, hereby REMISE, RELEASE, and FOREVER DISCHARGE any and all claims, demands, causes of action, damages, injuries, losses, obligations, and liabilities of every kind and character, whether actual or potential, presently known or unknown, now existing or arising in the future, disclosed or undisclosed, suspected or unsuspected, which Homeschoolers may now have, or may hereafter claim to have or to have acquired against the Released Parties, in both their individual and representative capacity, even if Released Parties or any of them are negligent, arising out of or incidental to any activity or event that Heritage Christian Home School plans, announces or is otherwise in any way connected with.

In addition to the above, Home schoolers further covenant never from this date forward to institute, prosecute, commence, join in, attempt, assert, or maintain any action against the Released Parties on any claim released by the foregoing paragraph in any civil or administrative proceeding, whether at law or in equity, in any Court or tribunal of the United States or any state thereof.

This Release shall take effect on the date hereinabove set forth or the date Homeschoolers first participate in any activity of Heritage Christian Home School, which ever occurs first. This Release is performable and enforceable in Houston, Harris County, Texas, and shall be governed by the laws of the State of Texas, which law shall be controlling in the event of any conflict of law.

This Release shall not release or effect in any way any claim arising out of the operation of a motor vehicle.
